

## Minutes of Meeting Held on 22<sup>nd</sup> May, 2010.

The following issues were discussed in the meeting and the consensus arrived at after deliberations. All present agreed unanimously to the following:-

### 1. Membership Fee Structure:-

The Fee structure was discussed at length and the following was agreed to:-

1) **Life Membership** – One time payment of Rs. 10,000/-.

2) **Adult Membership / Individual Membership** – Rs. 1,000/- Registration & Rs. 750/- Annual. 1<sup>st</sup> Year Rs. 1,750/-, thereafter Rs. 750 per annum.

3) **Student Membership Individual** – Upto Age of 22 Yrs. – Rs. 500/- Registration & Rs. 500/- Annual. 1<sup>st</sup> Year Rs. 1,000/-, thereafter Rs. 500 per annum.

4) **Club / Association Membership** – Every Club Shall be eligible for designating 1 (One) flying Field, within the under mentioned Fee Structure. In case of additional Flying Field request for designation, an amount of Rs. 1,500/- per flying field per annum shall have to be paid. A Club constitutes of 5 or more Members.

1<sup>st</sup> Year Rs. 3,000/- for Club + Rs. 500/- per member, thereafter Rs. 1,500/- per annum for Club and Rs. 500/- per Member, per annum.

5) **Trader** – Rs. 2,000/- Registration and Rs. 2,000/- Annual for 1 (one) Member. 1<sup>st</sup> Year Rs. 4,000/-, thereafter Rs. 2,000 per annum.

2. All Fee paid to AMA is Non – Refundable.

3. The Fee of AMA, (other than Registration) is for the Financial Year i.e. April to March.

4. As a one time deviation, all Members on the Register of AMA as on 31<sup>st</sup> July, 2010, shall be assumed to have paid their Annual Fee upto 31<sup>st</sup> March, 2011.
5. Under the 3<sup>rd</sup> Party Liability Insurance cover, only designated Flying Fields, where AMA Members fly, are covered. The two essentials, together are:-
  - a) The flying field should be a designated flying field, and
  - b) The Person flying should be a Member of AMA.

**Therefore, to cover AMA Members, it is essential that any flying field to be designated by AMA under the Insurance Policy, there must be at least 5 AMA Members.**

6. All Classes of Members shall be provided with ID Cards. They shall also have Insurance cover, subject to the essential prerequisites enumerated above.
